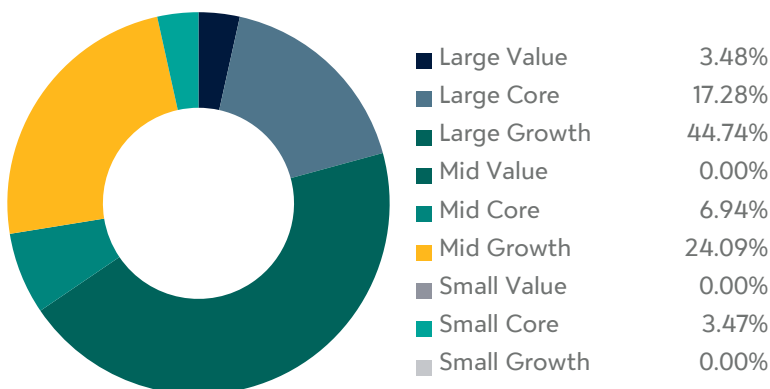
The strategy seeks long-term capital appreciation by investing in specific growth sectors that benefit the most from changing demographics of the population.

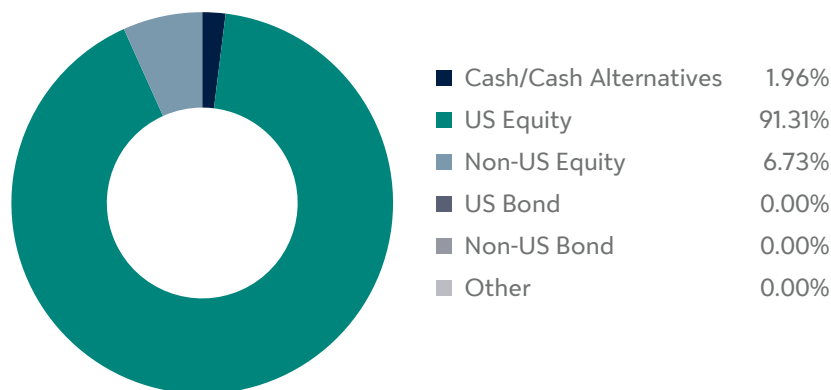
## What is the Millennium Strategy?
