

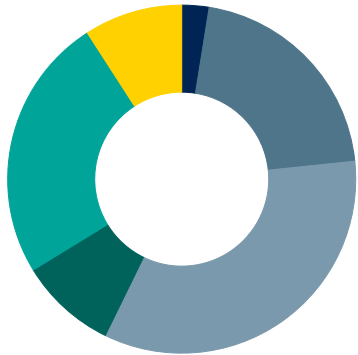
Objective & Strategy

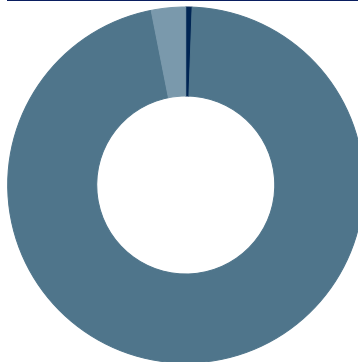
