

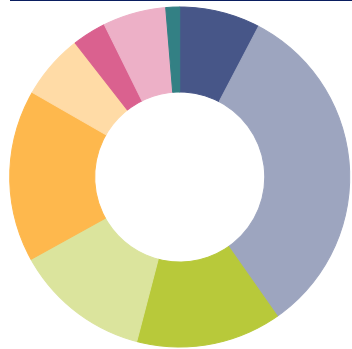
### Objective & Strategy
