

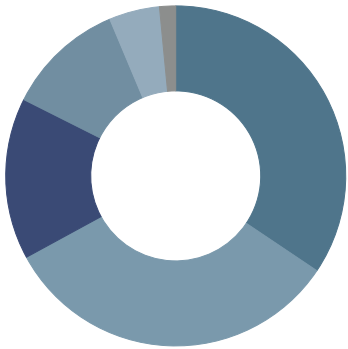
**Objective & Strategy**

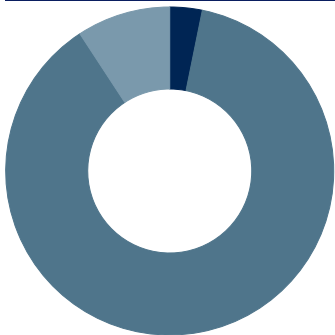
