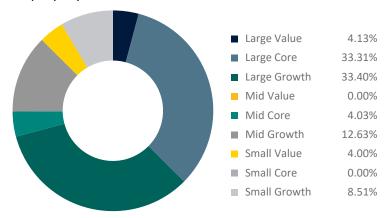

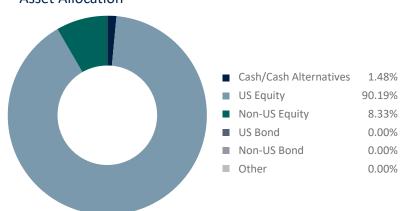
#### What is the AI Frontier?
