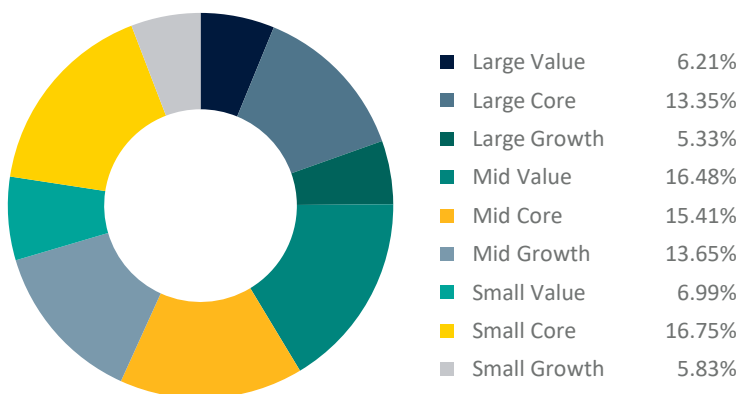

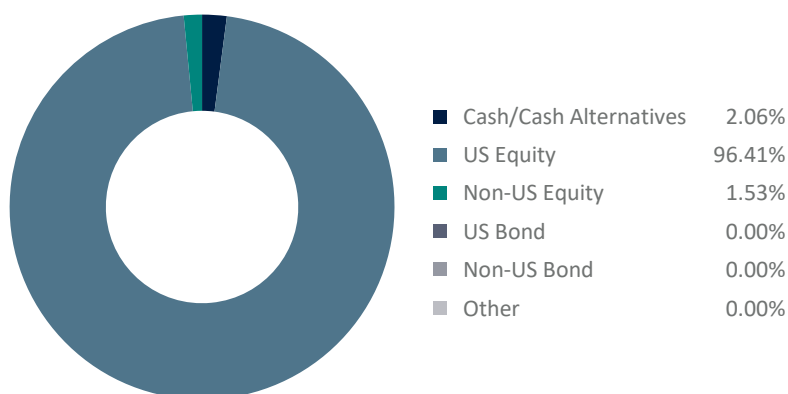
What is the Mid Cap Select Strategy?
