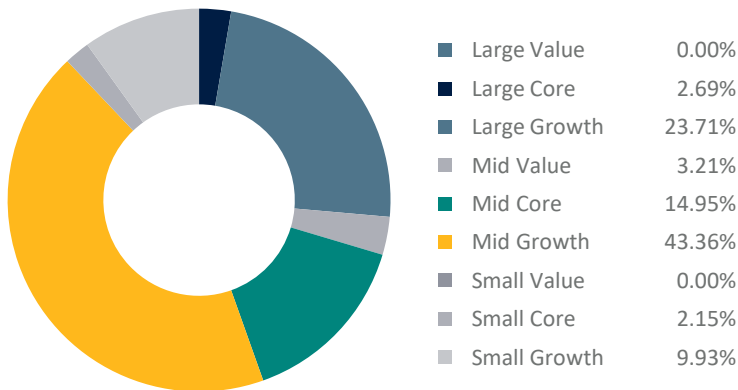

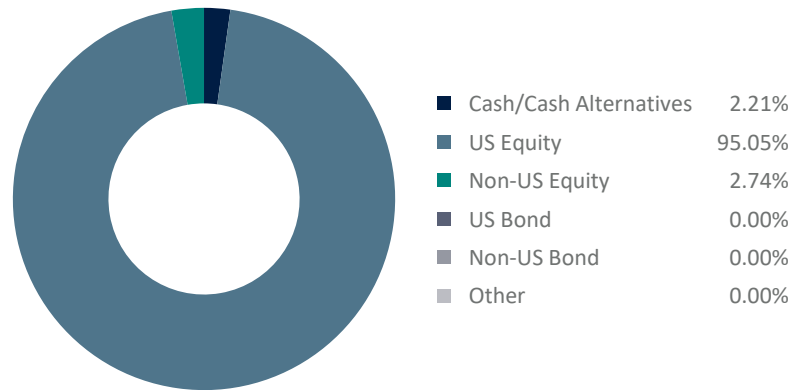
What is the Strategic Growth Strategy?
