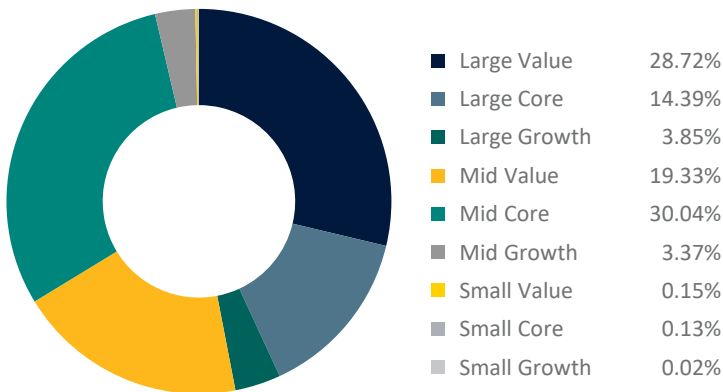
This strategy seeks to select securities that trade less expensively than the market average and achieve returns that exceed its benchmark.

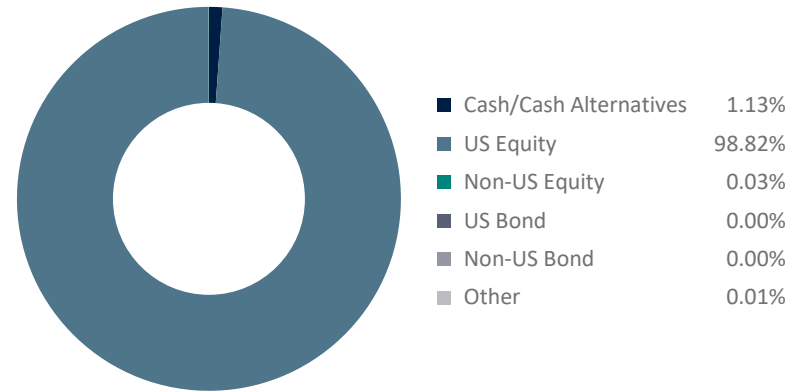
What is the Core Value Strategy?
