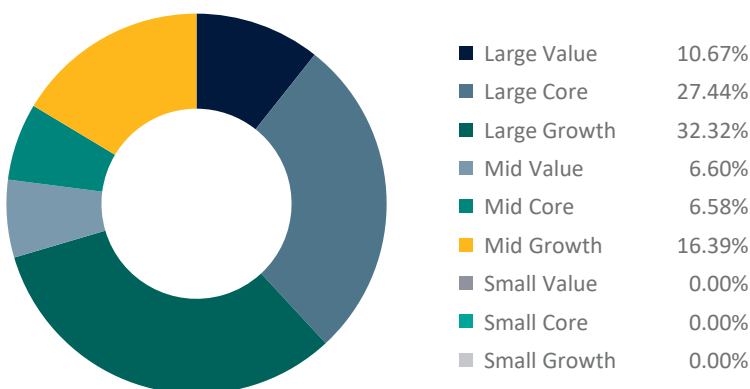

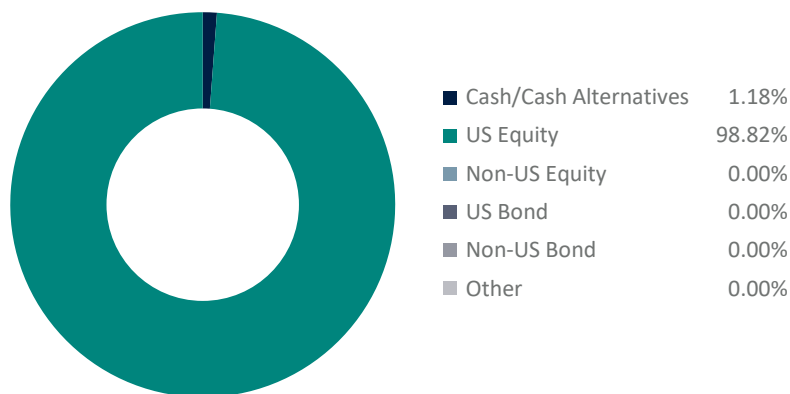
What is the Millennium Strategy?
